### Climate Change and the Madness of Crowds

Those who know me will know that I have been obsessing for years about so-called "climate change". I agree with the many unbiased independent scientists who refute the UN IPCC's unproven man-made CO2 global warming theory, such as Emeritus Professor of Physics Hal Lewis who resigned from his biased professional society using [strong words](#) which the biased establishment media never dared report:

*"The global warming scam ... is the greatest and most successful pseudoscientific fraud I have seen in my long life as a physicist."*

It seems to me that we are living through a "[Madness of Crowds](#)" period, like the Dutch tulip mania or the South Sea Bubble, with no sign yet of any "*Emperor's New Clothes*" realisation by our self-deluded politicians of the obvious truth that the "climate change" movement is not wearing a suit of fine clothes but is actually stark naked. A disturbing alternative interpretation is that it is all just a pretext for a "hidden in plain view" [UN agenda](#) to "*transform*" the world's economy. The problem is that the whole approach is not only senseless but destructive as well, with our incoherent, unworkable energy and climate change policies leading the country into [electricity blackouts](#), [industrial decline](#) and according to one commentator "[national suicide](#)", all for negligible climate or sustainability benefit.

I have been getting nowhere for years writing to ideologues like Fergus Ewing, Ed Davey and most recently Amber Rudd who have always stonewalled me in their replies with their politically correct, factually unfounded "climate change" assertions and mantras. I recently switched to the guerrilla war tactic of emailing all ruling-party Tory MPs, the only politicians who matter now on this issue. Whether or not this has had any impact I have no idea. The facts show that **man-made** global warming is a non-problem which does not even exist in the real world, only in the virtual reality world of the UN IPCC's hypothetical, simplistic, unvalidated computer climate models, only sustained by unfounded [Establishment propaganda](#).

My paper also explains why our decarbonisation policies are ineffectual and ruinous and why the unattainable emissions reduction targets of the Climate Change Act are certain to fail. It shows why the disastrous energy and climate change policies being pursued in a pointless effort to mitigate the indiscernible non-problem of **man-made** global warming are reckless to the point of irresponsibility, elevating the "precautionary principle" to an absurd level when we could just adapt to whatever happens (warming or cooling) as and when necessary.
